

Aqua Gems Swimming: Volunteer Bond

To all families,

Each year Aqua Gems host US Invitational Meets. These meets are major fundraisers for our Club. The meets are broken up into sessions and each family is requested to volunteer to work in **at least 4 sessions**. Such contribution is the essential factor for the success of the meets hosted by the club, and the success of the meet is the key factor to keep the paying dues of the families under control.

On sign-up, the Board requests each family to understand that you have to work in the meets hosted by Aqua Gems. Those meets are:

1. Early Bird meet in November
2. January Blitz meet in January

Every year, securing the necessary work force from the families has been one of the most difficult jobs for the Board. And that's why the Board introduces the Volunteer Bond for this 2011-12 season.

Here are the items that the Board would like you to understand:

1. This is your pledge to work a minimum of 4 sessions, and the Board will not deposit your check, as we believe that you will fulfill the minimum pledge. Your \$200 check will be held by the Board until the January Blitz meet is completed.
2. If you have fulfilled your 4 sessions of work, the \$200 check shall be returned to you "as is".
3. If you have not fulfilled your 4 sessions, the Board will deposit and cash your check after the January Blitz meet is completed, and we will issue a check for the portion you have worked. If you have worked for 3 sessions, we'll issue a \$150 credit to your account; 2 sessions, \$100; etc. No work, we'll keep all of your \$200.
4. From your family, at each session, if 2 persons worked, we'll count it as 2, of course. But, we only count members age 18 or older AND NOT a current swimmer.
5. If you do not stay for the complete session you are working in, it will not be counted.
6. It is YOUR RESPONSIBILITY to find the Volunteer Sign In Desk and sign in.

As above, this is NOT a FUNDRAISER, and the board wishes all the participating families to supply their work force equally. Therefore, the Board strongly wishes to return ALL the checks WITHOUT depositing them. If the 4 sessions are not completed, your check will be deposited.

So please submit a separate \$200.00 check **with the date of January 15, 2012**.
